This refers to the ongoing capacity development activities by the DENR Climate Change Service and USAID SIBOL on the three stages of the Green Assessment Framework (GAF). As a continuation, **Stage 2: Analysis and Interpretation** is scheduled from **May 13 to 17, 2024** in a venue within Metro Manila.

The Green Assessment Framework (GAF) is an assessment and planning tool that is utilized to determine the health of existing ecosystems, biodiversity, and communities in a post-disaster scenario and to inform recovery plans. It was first conceptualized and implemented by USAID-SIBOL as a response to the onslaught of Category 5 Super Typhoon Odette in December 2021. The following trainings have been conducted so far:
