# **PROCLAMATION NO. 512**

CREATING AND DESIGNATING SEVERAL PARCELS OF LAND LOCATED ALONG E. RODRIGUEZ JR. AVENUE, UGONG, PASIG CITY, AS A SPECIAL ECONOMIC ZONE (INFORMATION TECHNOLOGY PARK), PURSUANT TO REPUBLIC ACT NO. 7916, AS AMENDED BY REPUBLIC ACT NO. 8748

Pursuant to the powers vested in me under Republic Act (RA) No. 7916, or the "Special Economic Zone Act of 1995," as amended by RA No. 8748, and upon the recommendation of the Board of Directors of the Philippine Economic Zone Authority (PEZA), I, FERDINAND R. MARCOS, JR., President of the Philippines, do hereby create and designate several parcels of land, to be known as ARCOVIA CITY, subject to the provisions of RA No. 7916, as amended, its Implementing Rules and Regulations and PEZA Board of Directors Resolution No. 00-411 (s. 2000), as amended by Resolutions Nos. 04-295 (s. 2004) and 12-329 (s. 2012), and Resolution No. 18-067 (s. 2018), as a Special Economic Zone (Information Technology Park), located along E. Rodriguez Jr. Avenue, Ugong, Pasig City, with an aggregate area of One Hundred Twenty-Three Thousand Eight Hundred Thirty-Seven square meters (123,837 m²), more or less, as defined by the following technical descriptions:
