Dear Undersecretary Leones:

This refers to the FY 2024 Strategic Plans and Targets of the NCI-SRD National Steering Committee (NSC) as seen in the NCI-SRD Roadmap FY 2018-2030 2nd edition. As a backgrounder, one of the NSC's targets is to approve three proposed convergence areas annually. Moreover, a convergence area is a physical area where the DA-DAR-DENR-DILG NCI-SRD is implemented, which is identified based on selection criteria, supported by a CADP, proposed by the Local Government Unit (LGU), and approved by the National Steering Committee (NSC).

In this regard, may we request your good office to facilitate the coordination of the DENR Regional Convergence Initiative Technical Working Group (RCI TWG) with the DA-DAR-DILG RCI TWG and submit their proposed convergence areas through an endorsement letter to the undersigned with the following attachments to facilitate endorsement and review of the National Technical Working Group (NTWG) and National Steering Committee (NSC):

- 1. Draft Convergence Area (CA) Briefer (https://tinyurl.com/CAbriefer);
- 2. Resolution of the Regional Convergence Initiative Technical Working Group (RCI TWG) endorsing the CA; and
- 3. Endorsement of the CA from the LGU/s or Provincial/City/Municipal Convergence Initiative (P/C/MCI) TWG.

Further, for a step-by-step procedure on the selection of a convergence area and mobilization of the respective P/C/MCI TWG, you may refer to the CADP Manual of Operations 2022 which may be accessed via https://tinyurl.com/CADPManOps2022.

The National Secretariat will appreciate receiving the following documents on the following cut-offs to facilitate endorsement and review of the NTWG and NSC:

- Batch 1, May 15, 2024 cut-off date;
- 2. Batch 2, August 31, 2024 cut-off date; and
- 3. Batch 3, **October 31, 2024** cut-off date.


