This refers to the 4th DENR-TWG Meeting on the Codification of ENR Laws (Phase 1), held on 07 May 2024, 9:00 AM via Zoom, to discuss the status/progress of the project. The meeting was presided over by undersigned and participated in by the members of the TWG for Codification, PSD Chief and staff, and consultants and staff of the Center for Environmental Law and Policy Advocacy Inc. (CELPA).

Relative thereto, herewith are the agreements during the meeting:

1. The Bureaus concerned and NWRB will submit to PPS their conditional acceptance/concurrence on the draft Codes submitted by the CELPA on or before 10 May 2024. The additional comments that these offices may come up with will be considered by CELPA in the final outputs.
2. PPS-PSD will process the second tranche of payment to CELPA amounting to P2,599,675.00 on the basis of the conditional

acceptance/concurrence submitted by the relevant offices on the draft sectoral codes. The last tranche payment will be processed upon submission of the final outputs.

3. CELPA will coordinate with all the sectors/offices concerned for the finalization of the draft codes. While not discussed during the meeting, CELPA shall be required to submit the final outputs to the end-user on or before 17 May 2024.
