This refers to the meeting conducted on the proposed revision of the approving/issuing authorities for tenurial instruments under DENR Administrative Order (DAO) No. 2022-10 or the Manual of Authorities on Technical Matters, held on 17 May 2024 via Zoom.

Based on the latest guidance from our officials:

- The approving/issuing authority for tenurial instruments shall be the Supervising Undersecretary of the sector concerned
- The Undersecretary for Field Operations concerned shall be the concurring official on the recommendation of the Regional Executive Director (RED) with regard to tenurial instruments
- In the case of Mineral Agreements, the Secretary shall remain as the approving/issuing authority, as provided for under DAO No. 2022-10

MEMO NO. 2024 - 449

Herewith are the rest of the agreements/suggestions during the meeting:

Forestry:

- The approving/issuing authorities for the SLUP, GSUP, Provisional Agreement, Certificate of Stewardship and Management Plans, as provided for under DAO No. 2022-10 will be retained
- The approving/issuing authority for the renewal of tenurial instruments will be the RED
- The authority to cancel, suspend or terminate a tenurial instrument shall also be vested with the approving/issuing authority

Lands

- The authority of the REDs to approve Provisional and Revocable Permits, as well as Appraisal and Reappraisal of public lands as provided for under DAO No. 2022-10 will be retained
- Include in the revision of DAO No. 2022-10 the approving/issuing authority for the issuance of Order of Award

Biodiversity

- Provide recommendations on the signing authority for Memorandum of Agreements (MOA)
