This is in relation to the Mangrove Map Validation Initiative launched on February 28, 2024, we are pleased to announce its completion on June 30, 2024.

Thanks to your significant contributions in validating the presence and absence of mangroves via the ODK application and or submitting aerial images or shapefiles, we have currently surpassed our scientific target of 30,000 points by 50%.

The initial results are as follows:

- ODK App: Through the use of the ODK Collect application for 4 months, we achieved 9,500 points. 67% of the total ODK points were contributed by DENR and 33% by citizen science efforts.
- Aerial/geospatial data: Drone images submitted by both DENR and non DENR groups are currently under analysis and not integrated in the Mangrove Tracker Dashboard (Only for ODK app). As of July 8, the analysis and conversion of certain drone images has yielded 35, 912 points.

- Total: Initially, the total data entry points (ODK and drone) amounted to 45, 412 with ongoing increases expected as drone images continue to be processed.
