

1. OBJECTIVE


This procedure aims to standardize and properly document the processes undertaken by the NCI-SRD in the creation and approval of a Convergence Area Development Plan (CADP), and update section 8 of the NCI-SRD Procedural Manual.

2. SCOPE

This procedure applies to the NCI-SRD Working Group members, National Secretariat, Regional Convergence Initiative Technical Working Group members (RCI TWG), and Regional Secretariat.


3. DEFINITION OF TERMS

- 3.1 Convergence integration, complementation, harmonization and optimization of institutional, technical, financial and human resources
- 3.2 Convergence Area (CA) physical area where the NCI-SRD is implemented, which is identified based on selection criteria, supported by a CADP, proposed by the Local Government Unit (LGU), and approved by the National Steering Committee (NSC)
- 3.3 Convergence Area Development Plan (CADP) comprehensive plan that contains the strategies, programs, activities, and projects that will promote holistic and sustainable management of all resources within the convergence area
- 3.4 Convergence Initiative complementation of efforts and resources between and among the DA, DAR, DENR, DILG, LGU and relevant stakeholders to promote and harmonize the delivery of Agriculture, Forestry and Fisheries development services towards sustainable rural development
- 3.5 CADP Manual of Operations contains the general guidelines and processes that will guide relevant NCI-SRD stakeholders especially the Regional Convergence Initiative Technical Working Groups (RCI TWG), Provincial, City and Municipal (P/C/M) CI TWG on the implementation of projects, activities and programs (PAP) in convergence areas using the ridge-to-reef-approach



5. DETAILS

5.1 Proposals for Convergence Areas

- a. A call for convergence area proposals shall be disseminated by the National Secretariat every January of each year;
- b. Proposals for a new convergence area shall emanate from the concerned LGUs or the formed P/C/MCI TWG following the selection criteria stipulated in Sections 2.3.2 to 2.3.3 and endorsement of evaluation results by the P/C/MCI TWG stipulated in Section 2.3.3.2 of the CADP Manual of Operations 2022 to be validated by the RCI TWG;
- c. The RCI TWG shall endorse proposals for new convergence areas to the National Focal Person (NFP) through a formal endorsement letter with the following attachments:
 - i. RCI TWG Resolution endorsing the proposed convergence area;
 - ii. Convergence Area briefer based on the prescribed template; and
 - iii. Endorsement letter or resolution of the Sangguniang Bayan/Panlalawigan or the P/C/MCI TWG.



5.2 Approval of Convergence Areas

- a. The proposed convergence area briefer will be reviewed by the National Technical Working Group (NTWG) during their regular quarterly meetings;
- b. The National Secretariat shall endorse to the concerned RCI TWG and P/C/MCI TWG the comments of the NTWG 7 days after its regular quarterly meeting, if any, for the revision of the concerned RCI TWG and P/C/MCI TWG within 20 working days;
- c. The Policy and Advocacy (PA) Component Working Group (CWG) shall review the convergence area briefer. It shall also prepare and endorse to the NTWG the draft policy resolution approving the convergence area during its regular meetings;
- d. The NTWG shall conduct a final technical review of the proposed/revised convergence area briefer and corresponding policy resolution approving the convergence area during its regular meetings and endorse the same to the NSC;
- e. The NSC to approve proposals for new convergence areas through the issuance of a corresponding NCI-SRD joint policy resolution during its regular meetings;
- f. The National Secretariat shall disseminate the approved NCI-SRD policy resolution to the concerned RCI TWG for appropriate action, and upload it to the NCI-SRD website.

5.3 CADP Formulation

- a. The RCI TWG shall proceed with the preparation and drafting of the CADP of the newly approved convergence area following the outline and guidelines indicated in the CADP Manual of Operations 2022. RCI TWGs may include other sections/elements in the CADP, as may be appropriate or necessary;
- b. CADP workshops and writeshops may be conducted to support the drafting of the CADP of the newly approved convergence areas based on the request of the RCI TWG, which shall be funded by the National Secretariat and/or the RCI TWG, subject to the availability of funds;
- c. Draft CADPs produced from the workshops and writeshops shall be finalized by the RCI TWG with the P/C/MCI TWGs, as may be appropriate;
- d. Final draft CADPs shall be technically reviewed and validated by the RCI TWG before its formal endorsement to the NFP;
- e. Final draft CADPs shall be endorsed by the RCI TWG to the NFP through a formal endorsement letter with the following attachments:
 - i. Soft copy (PDF format) of the final draft CADP; and
 - ii. resolution of the Sangguniang Bayan/Panlalawigan or the P/C/MCI TWG.

5.4 Approval of the CADPs

- The NFP shall endorse the final draft CADP to the four component working groups for their inputs and recommendations in relation to their functions and mandates using the initial adequacy review checklist within 7 working days;
- b. The National Secretariat shall endorse comments of the CWGs, if any, and provide a consolidated initial adequacy checklist review for the revision of the concerned RCI TWG and P/C/MCI TWG within 20 working days;
- The National Secretariat shall provide a final adequacy checklist review for the CADP within 20 working days upon the revision and endorsement of the concerned RCI TWG:
- d. The PA CWG shall prepare and endorse the draft policy resolution approving the proposed CADP for implementation and funding of its PAPs;
- The RCI TWG and P/C/MCI TWG shall be formally invited by the National Secretariat to present its CADP during an NTWG regular meeting;
- The RCI TWG and P/C/MCI TWG shall prepare their summarized presentation of the CADP with the following outline:
 - Introduction/ Background/Rationale of the Convergence Area (3 minutes);
 - Area Situation including challenges with maps and photos (3 minutes); ii.
 - iii. Vision, Mission, Goals, and Objectives Statement (3 minutes);
 - Major interventions addressing the challenges with an illustration of the iv. master plan (3 minutes);
 - Plan Implementation Five-Year Work and Financial Plan summary (3 minutes)
- The NTWG shall conduct a final technical review of the final draft CADP and corresponding NCI-SRD resolution approving the CADP for implementation and funding of its P/A/Ps with the RCI TWG and P/C/MCI TWG in attendance and endorse to the NSC;
- The RCI TWG and P/C/MCI TWG shall revise the final draft CADP as may be required prior to the NSC's regular scheduled meeting and submit the revised final draft CADP to the National Secretariat;
- The NSC to approve the final draft CADP through the issuance of an NCI-SRD resolution approving the CADP for implementation and funding of its P/A/Ps during its regular meeting;
- The National Secretariat shall disseminate the approved NCI-SRD policy resolution to the concerned RCI TWG for appropriate action, and upload it to the NCI-SRD website.




