#### Introduced by REPRESENTATIVE NELSON L. DAYANGHIRANG

#### **EXPLANATORY NOTE**

The Province of Davao Oriental boasts of diverse natural tourist spots and is home to a wide array of natural resources. However, its abundant natural wealth is under threat from both natural disasters and man-made activities. Global Forest Watch, an initiative of the World Resources Institute that provides data and tools for monitoring forests in near real-time, estimates that the Province of Davao Oriental lost 9.99kha of humid primary forest between 2002 to 2021.


From this figure alone, it is evident that the protection and preservation of Davao Oriental's forests requires collaboration and coordination between the national and local government. As part of this effort, this representation proposes the establishment of community forests in the Municipalities of Baganga, Boston, Caraga, Cateel, Manay, and Tarragona in the First District of Davao Oriental.

A communal forest refers to a tract of forest land set aside by the Secretary of the Department of Environment and Natural Resources (DENR) upon the recommendation of the concerned local government unit (LGU) for the use of the residents of a city or municipality. The residents of the city or municipality may then cut, collect, and remove forest products for their personal use in accordance with existing laws and regulations and subject to the provision that utilization of resources therein shall be in accordance with sustainable development.

The establishment of communal forests will empower the residents and local communities in the First District of Davao Oriental to take a more active role in the responsible use, conservation, and management of their municipality's forest resources. Further, as the DENR will be mandated to provide technical assistance to the concerned LGUs in all facets of forest management planning, both the LGUs and local communities will be equipped with the necessary training and knowledge to ensure that their communal forests will be utilized in a sustainable manner and conserved through replanting activities.

In view of the foregoing, the approval of this bill is earnestly spught.



#### Introduced by Representative LORDAN G. SUAN

#### **EXPLANATORY NOTE**

This proposed measure seeks to establish community forests in Barangays Bayanga, Besigan, Dansolihon, Lumbia, Mambuaya, Pagalungan, Tumpagon, Pigsag-an, San Simon, Taglimao, Tagpangi, Tignapoloan, Tuburan, and Baikingon, all in the 1<sup>st</sup> District of Cagayan de Oro City.

A community forest is a tract of forest land set aside by the Secretary of the DENR for the use of the residents of a municipality or a barangay from which said residents may plant, re-plant, collect, and remove forest products for their personal use in accordance with existing laws and regulations.

A community forest provides several benefits, viz.:

- 1. Strengthens social cohesion by bringing people to work together.
- 2. Reduces deforestation thru a sustainable source of forest products.
- 3. Increases income and food security.
- 4. Provides tourism opportunities.

In view of the foregoing, approval of this bill is earnestly sought.

#### AN ACT

ESTABLISHING COMMUNITY FORESTS BARANGAYS  $\mathbb{I}\mathbb{N}$ BAYANGA, BESIGAN, DANSOLIHON, LUMBIA, MAMBUAYA, PAGALUNGAN, TUMPAGON, PIGSAG-AN, SAN TAGLIMAO, TAGPANGI. TIGNAPOLOAN. TUBURAN. BAIKINGON, IN THE FIRST DISTRICT OF CAGAYAN DE ORO CITY, PROVINCE OF MISAMIS ORIENTAL, AND APPROPRIATING FUNDS THEREFOR

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

SECTION 1. There shall be established, under the supervision of the Department of Environment and Natural Resources (DENR), community forests in Barangays Bayanga, Besigan, Dansolihon, Lumbia, Mambuaya, Pagalungan, Tumpagon, Pigsag-an, San Simon, Taglimao, Tagpangi, Tignapoloan, Tuburan, and Baikingon, in the First District of Cagayan de Oro City, Province of Misamis Oriental.

The DENR shall determine the size and specific forest limits of the community forest to be established within each of the barangay concerned.

Each established community forest shall be identified according to a Forest Land Use Plan, consistent with the city's land use plan, and all existing and related plans, programs, and projects of the city and national government.

SECTION 2. The DENR shall, within two (2) years after the determination and establishment of the community forests, transfer the management of the same to the local government unit (LGU) concerned, under the direct supervision of the City Local Environment and Natural Resources Office, through a memorandum of agreement. It shall implement a training and phasing-in program for local government personnel on the management, utilization and conservation of the community forests.

The DENR shall, in coordination with the concerned LGU, undertake a forest resource inventory in each of the barangays, determine the sustainable level of forest resource utilization and provide the LGU technical assistance in all facets of forest management planning. To ensure the sustainability of the community forests, the management plan shall include provisions for replanting by the communities and the LGUs.

SECTION 3. The DENR Secretary shall include in the Department's program the implementation of this Act, the funding of which shall be included in the annual General Appropriations Act.

The local government unit concerned shall set aside funds from any available local revenue in an amount deemed appropriate for the management, utilization, and conservation of the community forests.

SECTION 4. Within sixty (60) days from the effectivity of this Act, the DENR Secretary shall issue the rules and regulations necessary for the implementation of this Act.

SECTION 5. This Act shall take effect fifteen (15) days after its publication in the Official Gazette or in a newspaper of general circulation.
