

PROCLAMATION NO. 645

DESIGNATING SEVERAL PARCELS OF LAND, LOCATED AT BARANGAY KAMANGA, MUNICIPALITY OF MAASIM, PROVINCE OF SARANGANI, FOR INCLUSION INTO THE EXISTING KAMANGA AGRO-INDUSTRIAL ECONOMIC ZONE, PURSUANT TO REPUBLIC ACT NO. 7916, AS AMENDED BY REPUBLIC ACT NO. 8748

Pursuant to the powers vested in me under Republic Act (RA) No. 7916, otherwise known as the "Special Economic Zone Act of 1995," as amended by RA No. 8748, and upon the recommendation of the Board of Directors of the Philippine Economic Zone Authority (PEZA), I, FERDINAND R. 
