During the House Committee on North Luzon Quadrangle Hearing conducted on 31 July 2024, the Committee Members have requested several reports and policies to which the Department has committed to comply.

This is to reiterate the commitments made by DENR representatives, as follows:

1. Rep. Gato, Jr.: Issuance of a Department Order allowing the limited extraction of silica sand for the personal construction use of Batanes residents;
2. Rep. Dalog, Jr.: DENR policy on the accreditation of Mt. Province towns under the Batangan Forest Management System;
3. Rep. Bulut-Begtang: Written update/report on the hiring process for the vacant positions in DENR CAR;
4. Rep. Chungalao: Written report on DENR's land management activities in Alfonso Lista, Ifugao, and report on the Permanent Environment Protection Order in Mt. Polis; and
5. Rep. Primicias-Agabas: Request the logging reports and copy of the list of areas needing land surveys in her legislative district.
