In line with ARTA's mandate under Republic Act (RA) No. 11032, or the Ease of Doing Business and Efficient Government Service Delivery Act of 2018, the Authority has diligently been working on assisting agencies in streamlining their regulatory processes across various sectors in the country. ARTA's interagency streamlining flagship program, the National Effort for Harmonization of Efficient Measures in Inter-related Agencies (NEHEMIA) Program, operates on a sectoral basis with the goal of expediting processes, providing ease in doing business, and contributing to the realization of the government's socio-economic agenda. 
