Greetings from Anti-Red Tape Authority (ARTA)!

Pursuant to Section 17(k) of Republic Act (RA) No. 11032, ARTA is mandated to establish the Philippine Business Regulations Information System (PBRIS) that shall ensure the dissemination of and public access to information on the regulatory management system and changes in laws and regulations relevant to the public.

The PBRIS is an essential component of the National Regulatory Management System (RMS). Through its features, the PBRIS aims to improve the ability of the Philippine government to formulate, coordinate, implement, and assess regulations. These contribute to improving the quality of regulations and the regulatory environment in the Philippines. Upon full development, the system will enable and enhance the implementation of all RMS elements under regulatory planning, regulatory design, regulatory delivery, and regulatory learning.

Anent to this, we are pleased to announce that your agency has been selected as a priority participant for the **PBRIS Training of Trainers on September 19, 2024, from 8:00 am – 6:00 pm (venue to be announced)**. Attached is a copy of the program for your reference.

Moreover, we invite eight (8) representatives from 2 divisions of your agency to take part in this training.

The representatives should be occupying a **plantilla position** with the following criteria:

1. Four (4) Program Officers involved in policy/rulemaking and regulatory planning of your agency.
2. Two (2) Information Technology Specialist involved in digitizing monitoring system(s) of the agency.
3. Two (2) representatives from the office, authorized to approve the agency's regulation.

Since the activity entails the actual use of PBRIS, we require each participant to bring the following:

1. Laptop
2. Two (2) most recently approved agency regulations in Microsoft Word format or text-readable PDF for uploading in PBRIS.

Kindly register your agency at <https://tinyurl.com/PBRIS-ToT-B3D1> on or before **September 13, 2024**. This advanced registration will allow us to set up their accounts and generate Certificates of Appearance. Please note, after completing this training, it is crucial that all participants commence uploading regulations into the PBRIS at the start of **September 2024**. Your attendance and active involvement are highly valued for this process.

Lastly, the ARTA would like to highlight provision under Section 8 of RA 11032, which holds the head of office or agency to be primarily responsible for the implementation of the Act and accountable to the public in rendering a fast efficient, convenient, and reliable service.

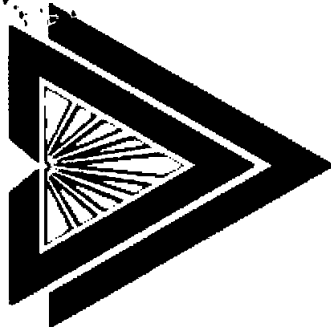
