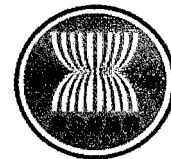

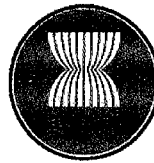

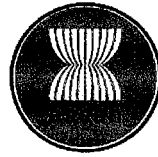

CONCEPT NOTE
ASEAN-PIF AND ASEAN-IORA DIALOGUE
IMPLEMENTING COLLECTIVE COMMITMENT TO ESTABLISH COOPERATION
Jakarta, 19 September 2024

A. RATIONALE

1. The world continues to face interlinked challenges, ranging from poverty, climate change, and economic inequality, to rising geopolitical tensions and conflicts. In the Asia-Pacific and Indian Ocean region, the challenges are primarily rooted in socio-economic inequality, limited resources, capacity constraints, and regional development disparities. Within this context, ASEAN as one of the most successful regional organizations is committed to contributing in shaping the Indo-Pacific region that is resilient, effective, and responsive to future regional and global challenges, in line with its vision to be the centre and driver of economic growth in the region and beyond.
2. This commitment to ensure inclusive development of the Indo-Pacific region is reflected in various ASEAN documents, including the ASEAN Leaders Declaration on ASEAN as an Epicentrum of Growth in 2023.
3. To follow up on this commitment, on 4 September 2023, at the sidelines of the 43rd ASEAN Summit, ASEAN signed a Memorandum of Understanding (MOU) with the Pacific Island Forum (PIF) and the Indian Ocean Rim Association (IORA), based on the view that ASEAN, PIF, and IORA represent a diverse spectrum of countries confronting similar challenges and opportunities in achieving a more sustainable and prosperous future for the Indo-Pacific region. The MoUs between ASEAN and IORA and between ASEAN and PIF focus on implementing the priority areas in the ASEAN Outlook on Indo-Pacific (AOIP), namely maritime cooperation, connectivity, Sustainable Development Goals (SDGs) 2030, economic and other possible areas of cooperation. Other focuses include the blue economy, people-to-people exchanges, and digital and green economies.
4. Even though the MoUs were signed only last year, several ASEAN activities were already undertaken, inviting participation from countries in the Indian and Pacific Oceans. Anticipating future cooperation activities between ASEAN and PIF and between ASEAN and IORA, there is a need to develop Frameworks of Cooperation (FOCs) with the two regional organizations, similar to the established practice between ASEAN and other regional organisations.
5. As mandated by the MoUs, the FOCs that would be developed between the organizations should serve to strengthen relationship through practical and feasible cooperation in areas of mutual interest. The (FOCs) are to incorporate elements of the existing MoUs and the evolving priorities of respective organizations.
6. Against that backdrop, Indonesia proposes and wishes to support the holding of a regional dialogue involving ASEAN, PIF, and IORA under the theme of "Implementing Collective Commitment to Establish Cooperation" in Jakarta, Indonesia, on 19 September 2024.

B. OBJECTIVE, PROPOSED DATE AND VENUE, PARTICIPANTS, AND FUNDING

Objective and Possible Outcomes
