Pursuant to Office of the President Memorandum Circular No. 64 s. 2024 dated 12 September 2024 and in observance of the 32nd National Family Week, which starts on 23 September 2024, DENR employees and persons hired under contract of service are hereby authorized to leave work after 3:00 P.M. today, 23 September 2024.

Proclamation No. 60 s. 1992 declares every last week of September as Family Week. On the other hand, Proclamation No 326 s. 2012 declares the fourth Monday of September as *Kainang Pamilya Mahalaga Day*. Employees are allowed to leave early from work on the first day of the National Family Week to spend time with their families, especially to share meals together.

MEMORANDUM CIRCULAR NO. 64

Pursuant to Proclamation No. 60 (s. 1992) which declared the last week of September of every year as Family Week and Proclamation No. 326 (s. 2012) which declared the fourth Monday of September of every year as "Kainang Pamilya Mahalaga" Day, work in government offices in the Executive branch shall be suspended on 23 September 2024 starting 3:00 p.m.

However, those agencies whose functions involve the delivery of basic and health services, preparedness/response to disasters and calamities, and/or the performance of other vital services shall continue their operations and render the necessary services.


This Office also encourages all government workers in the Executive branch to fully support the programs and activities relative to the observance of Family Week, as organized by the National Committee on the Filipino Family.


This Circular shall take effect immediately.
