This has reference to the invitation from the Board of Investment regarding the **Inter-Agency Meeting for Renewable Energy Investments on 05 February 2024** at the **BOI Penthouse Board Room, 385 Sen. Gil Puyat Avenue, Makati City.**

**BACKGROUND**

The Executive Order 18 was approved by the Office of the President on 24 February 2023 and was officially launched on 13 July 2023. The first project that was endorsed under the EO was the 1300 MW Floating Solar Power Project of SunAsia Energy Inc. in Laguna de Bay. Since then, the One-Stop Action for Strategic Investments (OSACSI) has already evaluated and endorsed 36 projects for Green Lane services, 28 of which are under the Renewable Energy (RE) sector. As of date, 21 out of the 24 projects that are still being evaluated by OSACSI are under the RE sector as well.

OSACSI has been proactive in coordinating with concerned government agencies as well as local government units in facilitating the applications of Green Lane endorsed projects. While agencies have been efficient in processing the applications of RE projects, there are still some challenges being encountered by investors that OSACSI aims to address.
