This is to follow-up on our request for input in the harmonization of data sets for the formulation of Ecological Profile for local development plans. This initiative is part of the ongoing collaboration of the DENR with the Department of Human Settlements and Urban Development (DHSUD) in enhancing the environmental sectoral analysis of local development plans.

DHSUD in partnership with DOST-PHIVOLCS and supported by World Bank, is developing the PlanSmart, a web-based, automated planning tool which aims to incorporate climate and disaster risk considerations into land use and urban planning. As part of this program, the PPS together with MGB, FMB, CCS, GDO, LMB, and NAMRIA provided input in the data mapping and attended the Data Mapping Results Presentation and Validation of harmonized data sets for ecological profile last May 24, 2024.

To ensure the accuracy and comprehensiveness of the environment and natural resource sector in the **Harmonized Ecological Profile**, we kindly request your input and validate the necessary data on the working document for the Harmonized Ecological Profile for PlanSmart.
