

3. Monitoring of accomplishments shall be in accordance with Section 5 of LC Committee Memorandum Order No. 1.
4. Composite L.C. Team No. 20 shall be in charge of the areas within the jurisdiction of Region IV-A and Composite L.C. Team No. 21 shall be in charge of the areas within the jurisdiction of Region IV.
5. All expenses to be incurred in connection herewith shall be charged against funds of the Bureau of Forest Development.
6. This Order is for the good of the public service and shall take effect immediately.
