SPECIAL ORDER No. | 190 Series of 1977

SUBJECT: Creation of the Coastal Zone Management Committee

Pursuant to Presidential Decrees No. 1121, 1151 and 1152, and in order to generate baseline information necessary in the formulation of policies and guidelines concerning the proper management of the country's coastal zone there is hereby created a Coastal Zone Management Committee composed of the following personnel:

In this connection, the Committee shall have the following functions, duties and responsibilities:

TECHNICAL GROUP

- Conduct a nationwide coastal zone survey in cooperation with the Natural Resources Management Center to determine their present status and utilization.
- Formulate a master plan to ensure the optimum utilization of these coastal zones taking into

consideration ecological and environmental conditions.

- Conceptualize and initiate plans, programs and projects which shall cause the wise and effective utilization of the coastal zones.
- Draft and recommend policies to the Executive Director of the NEPC, based on the findings and evaluation of the Committee.

SUPPORT GROUP

- Provide all the necessary administrative support in the pursuance of the functions, duties and responsibilities of the Committee.
- Gather and collect the necessary baseline information relative to the present system of coastal zone management of the country.
- Provide all other necessary support as may be needed by the Technical Group in the analysis and evaluation of the generated data and in the formulation of policies, plans and programs.

As such, travels that may be required by the Committee in the discharge of its functions, duties and responsibilities shall be on official time and authority is hereby given for the payment of traveling expenses and allowances as may be allowed under existing accounting and auditing rules and regulations.

Further, members of the Technical Group of the Committee are hereby authorized to claim reimbursable representation allowances/expenses subject to availability of funds and the usual auditing and accounting rules and regulations. Said members shall be entitled to collect a per diem of One hundred pesos (\$\frac{1}{2}\$100.00) for each meeting actually attended, provided said meetings shall not exceed three times a month.

To ensure the attainment of the objectives entrusted with the Committee, the same shall be under the technical administration and direction of the Executive Director of the National Environmental Protection Council.

This Order shall take effect immediately and all Orders/memoranda and/or parts thereof inconsistent herewith are hereby revoked and/or modified accordingly.
