Series of 1977) implement the DNR/BL Special
Project for Lungsod Silangan.

1. In order to effect the immediate implementation of project components of the DNR/BL Program for Lungsod Silangan, the following assignments are hereby made:
 - A. In addition to his duties as Officer-in-Charge of Region IV, Engr. Amante R. Dumag is hereby designated Project Director for the Lungsod Silangan Project. As Project Director, he shall act for and on behalf of the Secretary on all administrative matters except those affecting policies, monitor the various operational activities undertaken by the Bureau of Lands and coordinate with the DNR Planning Service with the view to facilitating implementation of the project components of the program.
