SUBJECT: Creation of a Security Survey/Inspection Team to conduct a nation-wide security surveys/inspections of all Regional and District Offices of the four Bureaus under the DNR.

The Security Survey/Inspection Team shall start from the regional down to the district levels in all bureaus under the Department. (Schedule attached)

Offices under survey or inspection shall give due cooperation on the conduct of the survey/inspection to facilitate and hasten its completion. The team may, in proper cases, avail themselves of the vehicular facilities and services of any personnel of the four bureaus under survey.

The team shall submit its report of the survey or inspection to the respective heads of the Regional Offices and District Offices surveyed, copy furnished Director of ISO-DNR and Bureau Directors within ten days after completion of each regional survey and inspection.

They shall be entitled to per diems, transportation allowances and other allowable expenses chargeable against their respective bureaus/offices, subject to the availability of funds and the usual accounting and auditing requirements.

The team leader is authorized to determine the manpower requirements in any particular survey area.

This order shall take effect immediately.
