SUBJECT: Designating Certain Officials to Staff the DNR Paoay Lake Development Project

1. In line with the President's directive to develop Paoay Lake and in consonance with R.A. 5631 dated June 21, 1969, a Project Committee is hereby organized to effect immediate implementation of the Paoay Lake Development activities, composed of the following:

2. The Committee shall prepare a comprehensive and integrated development plan for Paoay Lake, and coordinate all activities affecting natural resources in the area.


3. In addition to his duties, Engr. Arnold B. Caoili is hereby designated as representative of the Secretary in all matters affecting Paoay Lake Development. He shall act for and on behalf of the Secretary on all administrative matters, except those affecting policies. He shall also be responsible for monitoring and coordinating the operations of BFD, BFAR, and BL in the said area.

4. Regional Directors Taeza, Rosario and Batcagan are also hereby designated Field Operations Coordinators and they shall be responsible for the efficient and effective implementation of the aforesaid development plan.

5. Field personnel from the Bureaus shall report the progress of development activities to the Secretary, thru their respective Regional and Bureau Directors.

6. Members of the Committee are hereby authorized to claim P100.00/meeting called for purposes related to the project as representation/transportation allowances/expenses as may be authorized under existing regulations on the matter in connection with the above functions chargeable to the Special Activities Funds of the Office of the Secretary.

7. This Order shall take effect immediately and continue to be in force until revoked in writing.
