SUBJECT: Reconstitution of the NRSRC and Amend-
ing Certain Provisions of Special Order
No. 257 Series of 1979 and Special Order
Nos. 166, 175 and 225 Series of 1980

In order to strengthen the composition of the National Resettlement, Survey and Review Committee and its constituents and to ensure a unified, well-coordinated and more effective implementation of the resettlement program of the government as well as carry out the provisions of the Joint Administrative Order Series of 1979, on the Selection and Development of, and Jurisdiction over Resettlement Reservations, this Special Order is hereby promulgated to reconstitute the NRSRC and amend certain provisions of the above Special Orders, to wit:

As per Memorandum of Agreement, the NRSRC was created to effectively carry out the objectives of the national programs for resettlement and forest conservation through an acceptable system of delineating areas for resettlement purposes.

For this purpose, the NRSRC shall undertake the review of existing and proposed resettlement sites and the selection of new resettlement reservations based on guidelines provided for in the Joint Administrative Order.

The RCRSRT's on the other hand, are tasked primarily with the ground investigation of proposed or existing resettlement/settlement reservations that maybe referred to them by the NRSRC to determine compliance with the guidelines provided for in the Joint Administrative Order Series of 1979. The RCRSRT Team Leader may also invite representatives from other government agencies in the region which he deems necessary in the evaluation of certain resettlement projects.


Relative to the above functions, expenditures of the NRSRC and the Technical and Research Staff shall be charged to the Ministry of Natural Resources under its special activity entitled "Participation and Support Activities to Inter-Agency Projects on Agrarian Reform" or P/P/A 1.1.20 in the meantime that a common fund from the participating agencies is not yet available.

Members of the aforelisted Regional Teams shall be authorized to reimburse their transportation expenses chargeable against the Ministry of Natural Resources budgetary allocations under P/P/A 1.1.20.

Likewise the NRSRC members, the Technical and Research Staff and RCRSRT shall be entitled to a monthly honorarium which amount shall be subject to approved ranges by the Office of Compensation and Position Classification, Ministry of Budget and shall be subject to the availability of funds and in accordance with the existing accounting and auditing procedures.

All orders, circulars and memoranda previously issued/approved and/or inconsistent herewith are hereby revoked, amended or modified accordingly.

This Order shall take effect immediately.
