Mrs. Rosal shall be entitled to collect such per diems and travelling expenses as maybe allowed under existing auditing rules and regulations.

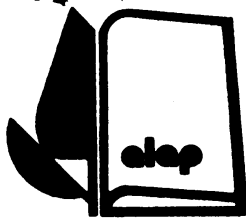
