The participation of the above-named officials and players in the said tournament and practice games shall be on official time effective September 1, 1981. The practice games, however, shall not exceed two (2) times a week. They shall be entitled to free uniforms, incidental expenses and an allowance of Thirty Five Pesos (\$\mathbb{P}\$35.00) per practice game and actual tournament participation, chargeable against any available amount for maintenance and other operating expenses of their respective Bureaus/Offices. However, the officials and players from the Office of the Minister shall charge their allowances and uniforms from the NRMC's allocation of funds, subject to its availability and usual accounting and auditing rules and regulations.

This order shall take effect immediately and shall be automatically revoked upon termination of the tournament.
