The Technical Sub-Committee which shall act as the principal coordinating Body for the preparation of the Five-Year Philippine Development Plan for the Natural Resources sector, shall undertake the following tasks:

- Formulate natural resources planning guidelines for the purpose of having a unified overall approach;
- Evaluate and integrate agency and regional plans into consistent components of the Plan; and
- Coordinate the generation of additional technical inputs necessary for the enrichment of the NR Plan.

Likewise, four (4) working groups shall be organized to assist the Technical Sub-Committee in the preparation of the Plan for the four (4) major sectors in natural resources, i.e., fisheries, forestry, lands and mines. These working groups shall be organized as follows:

- The Fishery Working Group shall have the FIDC as lead agency and representatives from the BFAR, NEDA, NRMC and MNR-OMIN, as members.
- The Forestry Working Group shall have the BFD as lead Agency and representatives from the PCWID, FORI, BL, NEDA, NRMC and MNR-OMIN. as members.
- 3. The Lands Working Group shall have the BL as lead agency and representatives from BFD, NEDA, NRMC, and MNR-OMIN as members.
- The Mines Working Group shall have the BMG as lead agency and shall have as members representatives from the MRDB, NEDA, NRMC and MNR-OMIN as members.

Each Sectoral Working Group is also encouraged to involve representatives of other appropriate government agencies and the private sector concerned. The Sectoral Working Group shall perform functions of the Technical Subcommittee for their respective sectors.

This Order shall take effect immediately.
