

The Over-All and Assistant Coordinators shall attend meetings/conferences of said activity and be responsible for monitoring and assisting the activities of the bureaus and attached agencies under the MNR while the trainers shall be responsible for training of the Ministry's contingent.

Under this Order, the above officials and employees are also authorized to attend calisthenics practices/rehearsals as provided in the above-mentioned Memorandum Circular. They shall be entitled to claim ₱170.00 for the prescribed uniform (rubber shoes, T-Shirts, socks and shorts) and daily allowance of ₱25.00 per practice (not exceeding 5 sessions) and ₱35.00 for the mass rehearsals and actual participation chargeable against the funds of the Office of the Minister, subject to the usual accounting and auditing rules and regulations.

This Order takes effect immediately and is automatically revoked upon the termination of said activity.
