**SUBJECT: MNR Sponsoring the Inter-Agency Workshop on the 200-mile EEZ to be held on the 26-27 February 1981 at the DAP Conference Center, Tagaytay City and Authorizing the Attendance of MNR Employees to the said Workshop**

In view of the Philippine interest in the proper implementation of the 200-mile exclusive economic zone and taking into account the need to form an inter-agency Committee on EEZ to be able to formulate consistent policies in the proper EEZ management acceptable to all agencies concerned, an Inter-Agency Workshop on the 200-mile EEZ sponsored by the Ministry with the attendance of MNR employees and other concerned agencies is hereby authorized. The workshop shall be held on 26-27 February 1981 at the DAP Conference Center, Tagaytay City.

The purpose of this workshop is to discuss, among other things the following:

1. The organization of an inter-agency body to ensure consistency of policies in the management of the zone and its resources,
2. To review different agencies activities on EEZ management, and
3. To draft a work program in the conduct of activities related to EEZ management for implementation of the Inter-Agency Body that will be created during the workshop.
