SUBJECT: Amending S.O. No. 336, Series of 1981, "Reorganization of the Planning Service" to provide for an OMIN-ASEAN Secretariat based in the Planning and Programming Division, Planning Service and to Modify the Composition of the MNR-ASEAN Coordinating Committee and the Secretariat

In the interest of the service and in view of the need for the continued existence of the MNR-ASEAN Secretariat to support the activities of the MNR-ASEAN Coordinating Committee, the Planning and Programming Division is hereby tasked to carry out as part of its activities, the functions of an OMIN-ASEAN Secretariat as follows:

1. Provide regular information to the MNR-ASEAN Coordinating Committee on ASEAN issues and other related matters.
2. Establish close coordination and cooperation at the working level with the Ministry of Foreign Affairs, Ministry of Agriculture, Ministry of Tourism, Ministry of Energy, Ministry of Industry and other Agencies involved in ASEAN.
3. Coordinate the preparation of necessary project proposals, position papers, evaluation papers, and other pertinent documents assigned to appropriate units/office by the Committee.
4. Attend to the various preparation and activities pertaining to ASEAN matters as assigned by the Committee.
5. Perform other functions that may be assigned by the MNR-ASEAN Coordinating Committee and/or the Minister.

The MNR-ASEAN Coordinating Committee shall continue to advise the Minister on the overall directions and guidelines for the implementation of ASEAN programs, projects and activities related to the natural resources sector as well as formulate and evaluate proposed programs, projects and activities for ASEAN.

To reflect the changes in personnel assignments, the composition of the Committee and the Secretariat is hereby amended effective 1 January 1982, as follows:


