
C. Officials

They are also entitled to an allowance of ₱ 25.00 per practice session which shall not exceed twice a week and ₱ 35.00 per actual game. These allowances shall be chargeable against their respective offices save the MNR IDEAL Coordinator who may draw his privileges hereto from the Bureau of Mines. Granting of these allowances shall be pursuant to MC # 1226 and subject to the usual accounting and auditing requirements.

This Order takes effect immediately and revokes automatically upon termination of the tournament.
