
In view of the significance of the forthcoming general assembly, authority is hereby granted subject, however, to the conditions that the attendance of government participants shall be on official time only at no expense from the part of the government except the salary of the person concerned. This is pursuant to the government policy of fiscal restraint and of Sec. 5.1.8 of Circular Letter dated November 18, 1977, implementing LOI No. 565 which states that private organizations shall invite government participation at conventions and other similar activities once in every two years. Records show that government participants were authorized to attend the GEWWVL Assembly on April 22-24, 1981 at Camp Aguinaldo, Q. City at government expense.
