SPECIAL ORDER

SUBJECT: Designation of District Land Officer Mariano M. Villanueva as Asst. Project Manager and District Land Officer Bienvenido S. Bermudez and Supervising Geodetic Engr. I Ildefonso P. Padigos as Project Officers for the Land Titling and Land Surveys Programs, respectively, of the Palawan Integrated Area Development Project in Palawan

1. In the interest of the service and pursuant to Special Order No. 23 (Series of 1982), District Land Officer Mariano M. Villanueva, District Land Officer Bienvenido S. Bermudez and Supervising Geodetic Engr. I Ildefonso P. Padigos are hereby designated as Asst. Project Manager, Project Officer for Land Titling and Project Officer for Land Surveys, respectively, of the Palawan Integrated Area Development Project.

2. District Land Officer Mariano M. Villanueva shall report directly to the Project Manager and shall perform the duties and function of the Office of the Asst. Project Manager and shall sign all official papers/correspondence as follows:

3. District Land Officer Bienvenido S. Bermudez as Project Officer for the Land Titling component shall assist the Asst. Project Manager in the overall coordination and supervision of the Land Titling works, coordinate with other government agencies concerned, spearhead the review of criteria used in Land Titling plans and submit project status report to the Asst. Project Manager.

4. Supervising Geodetic Engr. I Ildefonso P. Padigos as Project Officer for Land Surveys component shall assist the Asst. Project Manager in the overall management supervision of Land Surveys in coordination with other agencies involved, prepare detailed implementation plan, monitor implementation of the program and shall submit status report to the Asst. Project Manager.

5. The herein personnel shall assume the duties and responsibilities of their new designations in addition to their present duties and shall be detailed with the Palawan Integrated Area Development Project which will have its Office at Puerto Princesa City.


6. This Order shall not entitle them to preferential rights to promotion.
