January 14, 1983.


In the interest of the service, in response to the need of updating knowledge and skills of employees in relation to the promulgation of Ministry Administrative Order No. 50 Series of 1982, and in view of the invitation of the Federation of Cattle Raisers Association of the Philippines (FCRAP), the following are hereby authorized to attend the FCRAP Convention slated on January 14, 1983, at Makati Sports Club, Alfaro Street, Salcedo Village, Makati, Metro Manila:

1. Two representatives from the BL Central Office
2. Two representatives from BL Regional Offices
3. Two representatives from BFD Central Office
4. Two representatives from BFD Regional Offices
5. All members of the Ad-Hoc Committee on Pasture Lease created under Special Order No. 337 July 7, 1982 and any employee selected by its chairman to participate.

Representatives to be chosen should be actually engaged in range management or pasture lease matters or whose functions are directly related thereto.

Attendance to said convention shall be on official time and as such participants shall be entitled to collect per diems, allowances, and transportation expenses, chargeable against respective Bureaus/Regions/Offices appropriation, pursuant to the provisions of COA Circular No. 127, S. 1973, and subject to accounting rules and auditing regulations.

This order shall take effect immediately and only for the duration of the period needed to attend said convention.
