SPECIAL ORDER NO. <u>/0/</u> Series of 1983

SUBJECT: Assignment of Palawan-based and certain other personnel of the Bureau of Lands to the field operating units in the province of Palawan under the Palawan Integrated Area Development

1. <sup>2.</sup> The Assistant Project Manager for the Land Surveys and Titling Component is hereby authorized to deploy the above-named personnel of the Land Surveys Sub-Component to any areas within the province for the execution of the land survey activities of the PIADP, as well as to recommend to the Regional Director, Bureau of Lands Region IV, for the latter's designation as Deputy Public Lands Inspectors, whatever personnel are necessary to be designated as such to augment the investigation force for a successful execution of the activities under the Land Titling Sub-Component. The Assistant Project Manager for Land Surveys and Titling may further recommend to the undersigned the designation, in acting capacity, of other personnel detailed to the project to accomplish the work goals of the Land Surveys and Titling Component of the PIADP.

- 3. All expenses incurred by the aforementioned personnel in the performance of their duties by virtue of this Orders shall be chargeable against the PIADP funds for the Land Surveys and Titling Component subject to the usual accounting and auditing regulations.
- 4. This Order shall not entitle the foregoing personnel to preferential rights to promotion.
- 5. This Order shall have force and effect as of January 4, 1982, subject to the actual start of the performance of duties of the aforenamed personnel under their above assignments, as certified by the Assistant Project Manager for Land Surveys and Titling, and supersedes any previous orders, memoranda and/or letters which may be inconsistent herewith.
