Furthermore, in consonance with the previous Memorandum of Agreement signed by the heads of all participating agencies dated October 7, 1982, funds shall be provided for the technical and administrative operations of the said bodies. The member agencies shall make available the amount of P 360,000.00 for CY 1983 as follows:

Office of the Minister	P84,600
Bureau of Fisheries and Aquatic Resources	43,800
Bureau of Forestry	58,800
Bureau of Lands	39,600
Bureau of Mines and Geo-Sciences	54,000
Fishery Industry Development Council	34,800
Philippine Fisheries Development Authority	44,400

The Philippine Fisheries Development Authority (PFDA) shall act as fund administrator for the aforesaid amount to be released on a quarterly basis. It shall supervise the release of such funds intended to defray the necessary expenses of the MNR-ASEAN Coordinating Committee and the MNR-ASEAN Secretariat for its effective and efficient operations. However, such expenses/ expenditures to be incurred shall be subject to the approval of the Coordinating Committee.

This Order shall take effect immediately and shall remain in force until revoked in writing.
