To promote the full development of the cattle industry and to dispose expeditiously problems/ cases being referred to the Ministry for decision, an MNR Range Management Committee is hereby created under the Office of the Minister, which shall be composed of the following:

- 2. The Committee shall perform, among others, the following functions:
 - a. Assist in the formulation of appropriate policies/rules/regulations for the promotion and development of the cattle industry.

- b. Make an in depth study of the problems of the cattle industry and recommend solutions thereon to the Minister.
- c. Recommend/propose projects to accelerate the development of the cattle industry.
- d. Establish a mechanism to review, develop and monitor range policies and programs/ projects.
- e. Study/review cases on range management/ activities referred to the Ministry by the BFD/other agencies/private sector and recommend to the Minister measures/steps to be taken in such cases submitted for solution.
- f. Coordinate/monitor the smooth implementation of Ministry Administrative Order No. 50, s. 1982 and Ministry Order No. 4, s. 1982.
- g. Assist and advise the Minister in the review and study of range cases arising from land disputes and other cases affecting the operations of range and grazing lease or permit.
- h. Perform other tasks that may be assigned by the Minister from time to time.
- 3. The Committee is hereby authorized to seek the assistance of MNR officials and employees who are likewise directed to extend all the necessary assistance, support and cooperation.
- 4. In consideration of the services and to encourage the above listed personnel of MNR-BFD-BL to perform efficiently in the early disposal of pasture and range cases, they are hereby authorized to receive monthly honoraria effective January 1, 1983 pursuant to the provisions of LOI 565 and COA Circular No. 78-79 the amounts corresponding to their designation as indicated below:

Chairman - - - - - ₱900.00 Vice Chairman - - - 750.00 Members - - - - 500.00 Staff - - - - - 400.00 Funds for the purpose shall be charged against the appropriation of the BFD, subject to the usual accounting and auditing rules and regulations.

- 5. This Order amends MNR Special Order No. 337 dated July 7, 1982, and all other orders inconsistent herewith.
- 6. This shall take effect immediately.
