on official time. They shall likewise be allowed to hold their practice games twice a week. Further and as authorized by Memorandum Circular No. 1258 issued by the Office of the President, the said personnel shall be entitled to claim reimbursement for reasonable transportation expenses daily allowances not exceeding P40.00 per actual practice day and actual game, and other maintenance expenses, chargeable against their respective offices taken from any maintenance and other operating funds, subject to the availability of funds and the usual auditing and accounting rules and regulations.

The cost of uniforms, shoes, towels and socks for this team shall be shouldered by the Bureau of Forest Development.

This order shall take effect immediately and shall remain enforced until otherwise revoked.
