SUBJECT : Re-assignment of District Forester  
Rodrigo T. Bersamin from R2D-5,  
Cauayan, Isabela to R2D-4, Ilagan,  
Isabela.

1. In the interest of the service, and in line with the policy of this office to increase the technical skills of field personnel thru different working environment, District Forester Rodrigo T. Bersamin is hereby re-assigned from R2D-5, Cauayan, Isabela to R2D-4, Ilagan, Isabela.

2. He shall perform the functions of a District Forester and shall sign all official papers/correspondences as follows:

3. He shall clear himself of all work/property responsibilities and money accountabilities from his present assignment and report to his new place of assignment.

4. Expenses incurred in connection with his re-assignment shall be charged against the allotment of his new district assignment.


5. He shall inform this office thru the Regional Director concerned of his compliance herewith for record purposes.

6. This order takes effect immediately and cancels/supercedes all previous orders, memoranda and/or letters inconsistent herewith.



however, that in the case of the newly-created districts of Narra, and Coron, prior certification shall be submitted by the Regional Director, Region IV of the Bureau of Lands, that the office machinery of each of these new districts is so adequately set up that the said offices are now competent and capable to prepare, process and issue patents, before the Acting District Land Officers of these two new districts can sign patents, in accordance with the provisions of Republic Act 6516.

3. There shall be a turnover of office, property and records accountabilities from Mr. Villanueva to Mrs. Sebido in the District Land Office at Roxas, Palawan, after which they shall immediately render a joint written report thereon, through the Regional Director, Region IV of the Bureau of Lands and the Director of Lands, to this Office.
4. Mrs. Sebido and Mr. Sagalongos shall clear themselves of any records, money or property accountabilities in their respective present stations before assuming their corresponding new assignments, and shall inform this Office in writing, thru the Regional Director, Region IV of the Bureau of Lands and the Director of Lands, of the time and date the said Acting District Land Officers reported for duty in their respective new stations.
5. This Order is issued in the interest of the public service, and takes effect immediately.
