SUBJECT: Creation of an MNR Task Force and  
Committee to Review Regulations/  
Procedures on the Export of Natural  
Resource-Based Products

2. The Task Force and the Committee shall perform the following functions:
  - a. Review all existing rules/regulations/procedures governing the export of NR products;
  - b. Formulate simplified procedures and guidelines on the export of NR-based products;
  - c. Review other problem areas related to the export of NR-based products; and
  - d. Submit recommendation to the Office of the Minister within sixty (60) days upon the issuance of this Order.
3. The Chairmen of the Task Force and the Committees created are authorized to organize meetings/workshops and call upon its members in line with the aforementioned functions. All expenses to be incurred shall be charged against the appropriations of their respective agencies.

This Order shall take effect immediately and shall remain in force unless otherwise revoked.
