

Attendance of the above officials and players on actual games and practice sessions shall be on official time. Practice sessions, however, shall not exceed two (2) times a week.

They shall be entitled to free uniforms, reasonable transportation expenses and daily allowances of forty pesos (₱40.00) for actual tournament and practice sessions pursuant to MC #1258 chargeable against respective Bureaus/Office allocation of funds. Except, however, the officials and players from the Office of the Minister which shall charge their uniforms, transportation expenses and daily allowances to the Bureau of Forest Development Maintenance and other operating funds, however, subject to the availability of funds and the usual accounting and auditing regulations.

This order shall take immediately and shall remain enforced for the duration of the tournament.
