
SPECIAL ORDER

SUBJECT: Reassignment of certain District Land Officers and designation of an Acting District Land Officer, and an Officer-in-Charge of a Sub-Office, in Region IV of the Bureau of Lands

1. In the interest of the service and to strengthen the administrative machinery of certain district offices in Region IV of the Bureau of Lands, the following reassignments and designations of field officers are hereby made:
 - 1.1. District Land Officer Benjamin A. Arao is hereby relieved of his duties in Natural Resources District (NRD) IV-19 (District Land Office IV-A-5), Calapan, Or. Mindoro, and transferred to NRD-IV-20 (DLO IV-A-6), Roxas, Or. Mindoro, vice District Land Officer Norberto V. Malit who retired from the service on June 30, 1983;
 - 1.2. District Land Officer Jose C. Maulion, Jr. is hereby relieved of his duties in NRD-IV-8 (DLO IV_A-12), Real-Infanta, Quezon, and transferred to NRD-IV-19 (DLO IV_A-5), Calapan, Oriental Mindoro, vice Mr. Arao;
 - 1.3. Senior Special Investigator Constante Q. Asuncion is hereby relieved of his duties as Officer-in-Charge of Bureau of Lands Sub-Office IV-A-1(1), Balayan, Batangas, and transferred to, and is hereby designated Acting District Land Officer of, NRD-IV-8 (DLO IV-A-12), Real-Infanta, Quezon, vice Mr. Maulion; and
 - 1.4. Hearing Officer I Rogelio D. Paglinawan is hereby relieved of his duties as Officer-in-Charge of NRD-IV-20 (DLO IV_A-6), Roxas, Or. Mindoro, and transferred to, and is hereby designated Officer-in-Charge of, Bureau of Lands Sub-Office IV_A-1(a), Balayan, Batangas, vice Mr. Asuncion.
2. The present district land office at Infanta, Quezon may, in accordance with Section 1 of Administrative Order No. 52 dated December 1, 1982, continue to operate as such with territorial jurisdiction over Gen. Nakar, Real, Infanta, Polillo, Panukulan, Burdeos, Patnanongan and Jomalig until its relocation to Real and until the operationalization of NRD-IV-9 at Polillo, Quezon.

3. The above reassigned and designated officers shall clear themselves of any property, money and records accountabilities in their respective present assignments before assuming their corresponding duties in their new stations.
4. In each case there shall be a turnover of office from the incumbent to his successor, after which the parties concerned shall immediately render a joint written report thereon, thru the Regional Director of Region IV and the Director of Lands, to this Office.
5. This Order takes effect immediately.
