1. 2. The coordinating committee composed of the Regional Directors and Asst. Regional Director shall be responsible over the planning/programming and close supervision of the MNR-R-7 identified KKK prototype projects. They shall submit to this office periodic reports on the status of the KKK projects and shall likewise recommend and suggest certain action for policy formulation and recommendations.
3. The Secretariat, on the other hand, shall assist the Coordinating Committee on the smooth, efficient and effective implementation of the programmed activities.
4. In order to systematically carry out and implement the assigned duties and responsibilities, the above-mentioned officials and personnel are hereby authorized to claim compensation in lieu of overtime pay in consonance with LOI 565 but not to exceed herein authorized amount as ceiling:
 - a) Coordinating Committee - P650.00
 - b) Chairman/Vice-Chairman - P450.00
 - c) Members of the Secretariat - P300.00
5. The Chairman of the Coordinating Committee shall approve and claim upon recommendation of the Regional Directors concerned.
6. All claim for this purpose shall be drawn from the personal services savings of the respective Regional offices subject to the availability of funds and the usual accounting and auditing procedures, the MNR member of the Coordinating Committee shall draw his claims from the personal services savings of the BMG Region 7.
7. This Order takes effect starting January 1, 1983 and shall remain in force unless otherwise amended and/or repealed.
