SPECIAL ORDER NO. <u>529</u> Series of 1983

SUBJECT:

Designation of Supervising Geodetic Engineer DOMINGO B. GORDOVEZ and Supervising Land Examiner ROGELIO S. FODRA as Project Officers for Land Surveys and Land Titling, respectively, of the Palawan Integrated Area Development Project

- 1. In the interest of the service and to achieve more effectively the purposes of Special Order No. 23, series of 1982, Supervising Geodetic Engineer I DOMINGO B. GORDOVEZ is hereby relieved of his duties in Regional Land Office IV, Quezon City, and is hereby designated as Project Officer for Land Surveys of the Land Surveys and Titling Component, Palawan Integrated Area Development Project (PIADP), vice District Land Officer Bienvenido S. Bermudez who is hereby relieved of his duties in the PIADP and is hereby detailed in Regional Land Office IV for an eventual assignment to another District Land Office.
- 2. Likewise, Supervising Land Examiner ROGELIO S. FODRA, who has already been assigned as such to the PIADP under Special Order No. 120, series of 1982, is hereby designated as Project Officer for Land Titling of the Land Surveys and Titling Component, PIADP, vice Acting Project Officer for Land Titling Mariano M. Villanueva who is hereby relieved of his duties as such to enable him to concentrate on his higher duties as the Assistant Project Manager for Land Surveys and Titling of the PIADP by virtue of Special Order No. 42, series of 1982.
- 3. As Project Officer for Land Surveys, Engr. Gordovez shall directly assist the Assistant Project Manager for Land Surveys and Titling in the overall management, and supervision in the execution, of all survey projects under the PIADP in coordination with the other agencies involved; shall immediately be responsible for the said survey projects' execution; shall update the detailed survey implementation plan and momitor implementation of the program; and shall submit periodic status reports thereon, thru the Assistant Project Manager for Land Surveys and Titling, to the Project Manager of the MNR Component, PIADP.
- 4. As Project Officer for Land Titling, Mr. Fodra shall directly assist the Assistant Project Manager for Land Surveys and Titling in the overall coordination and supervision of the project's land titling activities; shall coordinate with other government agencies concerned; shall update the land titling plans and program and monitor implementation of such program; and shall submit periodic status reports thereon, thru the Assistant Project Manager for Land Surveys and Titling, to the Project Manager of the MNR Component, PIADP.

- 5. There shall be an immediate turnover of all survey records of the Land Surveys Sub-Component from Mr. Bermudez to Mr. Gordovez, after which a joint report thereon shall immediately be submitted by them, thru the Assistant Project Manager for Land Surveys and Titling, to the Project Manager of the MNR Component, PIADP.
- 6. This Order shall not entitle the above-designated officers to preferential rights to promotion.
- 7. The expenses the aforementioned officers will incur in complying with this Order shall be charged against the PIADP funds for Land Surveys and Titling in the case of Messrs. Gordovez and Fodra, and against the funds of Regional Land Office IV with respect to Mr. Bermudez, subject to the availability of such funds and to the usual accounting and auditing requirements.
- 8. This Order takes effect immediately, and amends or supersedes any previous orders which are inconsistent herewith.
