Ramos - Driver The Coordinating Committee composed of the Regional Directors shall be responsible over the planning/ programming and close supervision of the MNR-Region 02 identified KKK prototype projects. They shall submit to this office periodic reports on the status of the KKK projects and shall likewise recommend and suggest certain actions for policy formulation and recommendations. 3. The Secretariat, on the other hand, shall assist the Coordinating Committee on the smooth, efficient and effective implementation of the programmed activities. 4. In order to systematically carry out and implement the assigned duties and responsibilities, the above-mentioned officials and personnel are hereby authorized to claim compensation in lieu of overtime pay in consonance with LOI 565 or representation expenses but not to exceed the herein authorized amount as ceilings: a) Regional Directors - ₱500/mo. b) Asst. Regional Directors - 400/mo.

c) Chairman of the respective Secretariat - P350/mo.

d) Members of the Secretariat - 300/mo.

e) Drivers - 200/mo.

- 5. The Chairman of the Coordinating Committee shall approve all claims upon recommendation of the Regional Directors concerned.
- 6. All claims for this purpose shall be drawn from the personal services savings of the respective Regional Offices subject to the availability of funds and usual accounting and auditing procedures.
- 7. This order takes effect starting April 1, 1983 and shall remain in force until otherwise amended and/or repealed.
