The Composite Team shall implement the provisions of letter B, No. 1, 2, 3 and No. 7 of memorandum dated August 30, 1983 and shall confer/coordinate with Mr. Rogelio J. Bolivar, over-all coordinator on Range/pasture matters regarding the said implementation.


The Local Implementing Committee shall assist and support the Composite Team in the implementation of policy, guidelines, rules/regulations, decision instructions and orders promulgated by the Composite Team.

The Composite Team/Local Implementing Committee may call the assistance of any personnel or may utilize any available vehicle or equipment in the Region/District that may be needed to accomplish its objectives or functions.

The members of the Composite Team/Local Implementing Committee and any employee called upon to assist in the carrying of its functions/purposes while out of official station shall be entitled to collect per diems, allowances and transportation expenses, chargeable against respective Bureaus/Regions/Offices appropriation pursuant to the provisions of COA Circular No. 127, S. 1983 and subject to accounting rules and auditing regulations.

The Composite Team and the Local Implementing Committee hereby created shall plan its activities, schedule its work and submit its accomplishment report periodically or as may be needed.

This Order shall take effect on January, 1, 1984, amends/revokes/cancels existing memorandum/order inconsistent herewith and shall remain in full-force and effect until revoked by the undersigned in writing.
