1. 2. The MNR-KKK RCC Board shall be the policy-making and implementing body of MNR-KKK Projects in Central Luzon. It shall formulate guidelines, rules regulations and standards consistent with policy instructions of the Ministry. It shall submit to this Office periodic reports on the status of MNR-KKK Projects and shall likewise recommend actions for policy formulation.
3. The RCC Secretariat shall provide administrative and support services to the RCC Board in relation to the implementation of MNR-KKK Projects. It shall evaluate all on-going MNR-KKK Projects. It shall evaluate all proposed projects before submission to the RTC and the Regional Action Officer.
 - 3.1 Support service unit of the Secretariat. The service unit shall provide support to the Secretariat. It shall keep records and documents of all MNR-KKK Projects. It shall attend to the needs of the Regional Coordinating Committee relative to meetings, conferences and seminars.
4. Research and Planning Group - It shall be the planning body of the RCC with regards to KKK program implementation. It shall prepare MNR-KKK plans, composed of annual plans, five-year plans and long range plans. It shall also prepare Annual Budget for the operations of MNR-KKK Projects.

5. The MNR-KKK Technical Body shall review the technical aspects of KKK Projects for the Secretariat. It shall prepare prototypes for all MNR-KKK Projects. It shall provide criteria for standards used in project evaluation.
6. The RCC Documentation and Information Group shall prepare information program for the MNR-KKK Projects. It shall prepare sound-slides documentaries for the MNR Management conferences. It shall undertake information and relation activities for the KKK projects.
7. In order systematically carry out and implement the assigned duties and responsibilities, the above mentioned officials and employees are hereby authorized to claim, compensation in lieu of overtime pay in consonance with LOI-565 dated June 30, 1977 but not to exceed herein authorized amount as ceiling.
 - a) MNR KKK RCC BOARD
Chairman and co-chairman - P600.00/Mo.
 - b) Members - Asst. Regional Directors & OIC - P500.00/mo.
 - c) RCC Secretariat - P500.00/mo.
 - d) Support Service Unit of the Secretariat - P300.00/mo.
 - e) Research and Planning Group - P400.00/mo.
 - f) MNR-KKK Technical Staff - P400.00/mo.
 - g) RCC Documentation & Information Group - P300.00/mo.
8. The Chairman of the Coordinating Committee shall approve all claims upon recommendation of the Co-Chairman and/or Committee members concerned.
9. All claims for this purpose shall be drawn from the allotment of the respective regional offices subject to the availability of funds and usual accounting and auditing procedures.
10. This order takes effect starting January 3, 1983 and shall remain in force unless otherwise amended and/or repealed.
