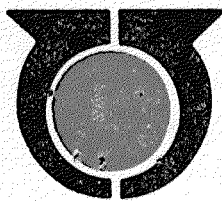

SUBJECT: Authorization for Ministry of Natural Resources and Bureau of Lands officers and employees directly involved in the Land Surveys and Titling Component, Palawan Integrated Area Development Project, to claim monthly reimbursable representation and transportation allowance

- A. 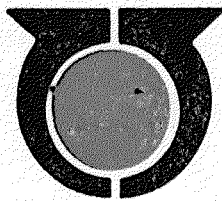
