- prepare the necessary documents and equipment. for the field studies
- undertake field studies in the Kalayaan Islands which would include:
 - determination of the density and diversity of the marine flora and fauna
 - determination of the extent of the coral reef and the total coral cover percentage
 - determination of the diversity of fish species in the area
 - conduct hydrobiological studies including chemical analysis, current velocity and direction readings; water transparency and temperature readings

- explore the possibility of plankton sampling
- conduct survey and habitat analysis of marine turtle and sea birds
- obtain secondary information on the fishing activities in the area
- collation of all data gathered.

The project leader is hereby authorized to hire additional personnel which he may deem necessary in the implementation of the project.

The above members of the team and additional personnel which may be hired for the project are also granted the authority to collect monthly honoraria effective January 1 to December 1983 in the amount specified below:
