- 2) The Task Forces shall perform, but not necessarily be limited to the following activities:

- a) solicit and evaluate activity proposals related to their respective component for possible implementation under the RRDP objectives;
- b) evaluate the proposals submitted by different consultancy firms to undertake the activities under packages I MNR/MA Resource Policy Management and II (MA Farming System);
- c) inspect the proposed sites under the activity proposals;
- d) monitor the implementation of the respective activities under each component; and
- e) participate in the review, evaluation and formulation of objectives of the RRD project.
- 3. Function of the Program Support

a. Technical

- 1. Extend technical support to the TCC
- 2. To supervise monitoring and evaluation of ongoing activities
- To design plan of documents upon consultation with RRDP top management

b. Administrative

- Extend clerical assistance to the Technical Staff;
- 2. Maintain the records, reports of the RRDP
- 3. Perform other Administrative functions
- 4. Each Task Force member shall attend meetings and/or conference germane to the efficient implementation of the RRD project;
- 5. The Task Force members shall be entitled to claim honoraria or allowance, travelling and other expenses in the performance of their duties under the respective RRD project component.

Other expenses to be incurred in connection with the RRD project shall include expenditures for hosting of meetings and workshops as those to be incurred in the preparation and packaging of reports, and such other expenses necessary for the implementation of the project. All the aforementioned expenses shall accordingly chargeable against the funds appropriate for the RRD project, subject to the usual accounting and auditing procedures.

- 6. The functions and existence of the Task Forces shall be co-terminous with the entire duration of the project or depending upon the recommendation of the Director of Foreign-Assisted Projects Management Office to the Minister, when he deemed it wise, the existence of the Task Forces shall be abolished.
- 7. This amendment and/or addendum shall be construed in harmony and without overlapping effect to the provisions of Special Order No. 573, Series of 1982. In so far as conflict, doubt and the like arise, this Order shall prevail.
- 8. This Order shall retroact to the effectivity of the Special Order No. 573, Series of 1982.
