SUBJECT: Authority for additional Bureau of Lands officers and employees involved in the execution of various integrated area developmental activities in the province of Palawan to collect monthly reimbursable representation and incidental allowances

- A. In the interest of the service and to provide incentives as well as to enable them to cope with the spiralling cost of commodities, clothing and shelter in the execution of the various integrated area developmental activities in the province of Palawan, the following additional personnel of the Bureau of Lands Region IV are hereby authorized, pursuant to the provisions of paragraph No. 5 on extra services of Letter of Instructions No. 565 dated June 30, 1977 and Guidelines I-B (1) (d) and B (2) (C) of COA Circular No. 78-77 dated February 28, 1978, and subject to the availability of funds and to the usual accounting and auditing requirements, to claim monthly reimbursable representation and incidental allowances effective March 1, 1984 but not beyond June 30, 1984, at the rates respectively indicated after their names:
