The MNR-KKK District Coordinators had the task of identifying and prioritizing projects at the District level. Monitor the organization accomplishment and status of MNR-KKK activities. They shall evaluate the project's feasibility studies. Work closely with the proponents in ensuring timely delivery of assistance and services and monitor the progress report of the on-going and pipeline projects.

The MNR-KKK District Action Officers shall render technical assistance in the preparation of project feasibility studies (PFS) and/or validation of prototype projects. They shall appraise and endorse to the District Coordinator for final evaluation all MNR-KKK projects including those recommended by other entities for KKK funding. They shall assist/train KKK beneficiaries on project implementation. And shall render technical assistance on production and marketing activities.

The Extension Workers shall be assigned to supervise MNR-KKK projects from the time the loan is approved and released and closely follow-up the repayments. They shall assist in identifying and mobilizing potential beneficiaries including the preparation of project feasibility studies. Submit reports thru the District Coordinators on the status of project operations under their supervision.

The support staff shall assist in the gathering of data and preparation of documents for KKK funding. They shall provide services in the documentation of on-going MNR KKK projects including typing, recording and filing of MNR-KKK correspondences/reports as well as published news report for the information of general public and media consumption.

In order to systematically carry out and implement the assigned duties and responsibilities, the above mentioned officials and personnel are hereby authorized to claim compensation in lieu of overtime pay in consonance with LOI 565 but not to exceed herein authorized amount as ceiling:

1.	MNR-KKK Coordinator/MNR Staff	⊉500.00/mo.
2.	District Coordinators	250.00/mo.
3.	District Action Officers	200.00/mo.
4.	Extension Workers	150.00/mo.
5.	Support Staff	100.00/mo.

It is understood that all claim for this purpose shall be charged against the Regional Office subject to the availability of funds, usual accounting and auditing procedures.

This Order takes effect starting January 1, 1984 and shall remain in force unless otherwise amended and/or repealed.
